National Extra Provincial Registration Services

Note: [Northwest Partnership Free Trade Agreement](#) (NWPTA)

Alberta, British Columbia, Manitoba, and Saskatchewan have entered the NWPTA agreement allowing for ease of business and trade across the borders of these 4 Provinces. Under this agreement companies who are incorporated in any of these 4 Provinces do not pay the Government fees to register in the one another's Province. These companies also do not need to file annual renewals in each jurisdiction.

Example: An Alberta Corporation registering in Manitoba, BC and Saskatchewan would not pay any government fees to do so. Only the Name reservation and service fee applies. When calculating fees for your clients, be sure to review the home jurisdiction registration and determine if the company is registered in one of these 4 Provinces and attempting to register in the others. All other jurisdictions will be required to pay Government fees in these Provinces.
